

1. Carry your Contract with you at all times!
2. Check your paystubs against CrewTrac to ensure you are paid correctly.
3. Keep only 1 phone contact on file with Scheduling.
4. Respond to Scheduling only when you are contractually required to do so.
5. Always keep a note pad and pen by the phone. Record the day, the time, the name of the Scheduler and the entire flight assignment you are given, from report to release back at domicile.
6. If you believe your Contract has been violated call the Helpline at: (317) 429-0759 ASAP. Please have all your info ready. (e.g. pairings, pay stubs, etc.)
7. Protect yourself by having a Union Rep. with you for ANY meeting or discussion with management that could result in discipline. Tell management you are prepared to discuss the matter as soon as Union representation can be arranged.



Rules to Fly By!

Duty Time Limits and Minimum Rest Requirements in accordance with FAR 121.467 and the 2005-2009 IBT/RAH F/A Contract

Sked'd. Duty Day	Minimum Rest Period	Reduced Rest Period	Min. Rest following Reduced Rest
14 hrs or less	9 Hours	8 Hours	10 hours
14-16 Hours	12 Hours	10 Hours	14 Hours

Article 24 B.2. States: "A Flight Attendant scheduled for a reduced rest overnight will be scheduled for no more than ten (10) hours of duty in her next duty period."

Article 6 K. 5. b. vi. States: Assign her to another pairing with a scheduled release time no more than 2 hours later than the scheduled release time on the last day of her original pairing;
